## WACO/WSAC Joint Conference Reminder!

Pack your bags and gas-up the car! The 2<sup>nd</sup> Annual Joint WACO/WSAC Fall Conference is this coming week at the DoubleTree SeaTac Hotel. All staff efforts are directed at finishing the preparations to make this conference a great one so this edition of the Courthouse Journal will include only the conference program and recent election results. ## Senior WSAC Member Suffers Loss in Primary Election

King County Councilmember, Cynthia Sullivan (D), was defeated in a close primary election last week ending a 20 years on the King County Council. Sullivan, Chair of the county council, was first elected in 1983 and is the senior member within WSAC. She was defeated by Bob Ferguson (D). Ferguson will replace Sullivan beginning next January.

In other election returns Grays Harbor Commissioner Al Carter (D) won a special election against three other Democrats. He was appointed earlier this year to replace Dan Woods who had resigned. Another appointed commissioner, Dennis Bly from Lincoln County won his primary against a single Republican opponent. He was appointed to replace Bill Graedel. Both members will be elected in the general election with no opponent from the opposite party.

In other races affecting WSAC members Mark Rose (D) will oppose Pat Rodgers (R) in Jefferson County in the general election. This position is open because Wendi Wrinkle was elected last year, but resigned this Spring and the appointed commissioner, Judi Mackey chose not to file for the remaining term.

Other contested races for WSAC members that will go to the general election ballot are incumbent Steve Tharinger (D) and challenger

Sue Forde (R) in Jefferson; incumbent Dow Constantine (D) and Michael Nelson (L) in King County; incumbent Steve Hammond (R), who was appointed to replace Kent Pullen when he died earlier this year, will be opposed by Barbara Heavey (D) in King County; incumbent David Irons (R) will be opposed by former King County Councilmember Brian Derdowski (D); incumbent Bruce Coe (R), who replaced Bill Hinkle when he was elected to the Legislature last year, will be opposed by David Gerth (D) in Kittitas County; incumbent Gary Nelson (R) will be opposed by D.J. Wilson (D) in Snohomish County.

In the Executive's race in Snohomish County State Senator Aaron Reardon (D) will be opposed by Dave Earling (R). Bob Drewel is the incumbent and is term limited by the county charter.

In Whatcom County the positions are non-partisan. Incumbent Dan McShane will be opposed by two opponents, Kerry Chappel and Chuck Lind. Incumbent Sam Crawford will be opposed by Kike Kaufman.
